PLEASE READ THE FOLLOWING INFORMATION CAREFULLY

To enroll in the American Red Cross Lifeguarding course, you must be at least 15-years-old before the last scheduled class session. To participate in the American Red Cross Lifeguarding course, you must be able to demonstrate the following skills:

- Swim 300 yards continuously demonstrating breath control and rhythmic breathing, using freestyle and/or breaststroke.
- Tread water for 2 minutes using only the legs.
- Starting in the water, swim 20 yards using front crawl or breaststroke, surface dive 7-10 feet, retrieve a 10-pound object, return to the surface, swim 20 yards back to the starting point with the object and exit the water without using a ladder or steps, within 1 minute, 40 seconds.

Participants must meet all skill evaluation requirements listed above. JCPCDD does not guarantee that every student will pass their purchased certification course. The American Red Cross Lifeguard Course has minimum academic, skill and physical standards. To obtain certification, the student must satisfy all certification course requirements. If the student should fail to satisfy all certification course requirements, JCPCDD cannot generate a refund to the student. If the student has any questions as to the certification course requirements, the student should contact JCPCDD staff prior to purchasing the certification course.

Refunds are only available if the class is cancelled due to low enrollment.

A refund will not be issued if participant fails the swim test or misses the first day of class.

JCPCDD does not guarantee employment to participants that pass the course.

Participants must attend all course dates, unless authorized by instructor.

WAIVER FOR ADULTS: FITNESS, SPECIAL EVENTS, AQUA AEROBICS, CLINICS

In consideration of being permitted to enter the Julington Creek Plantation Community Development District ("JCPCDD") facilities for any purpose whatsoever, including, but not limited to observation, use of facilities or equipment, or participation in any way, the undersigned, for himself or herself and any personal representatives, heirs and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering will, inspect such premises and facilities. It is further warranted that such entry into the JCPCDD facility for observation, participation or use of any facilities or equipment constitutes an acknowledgement that such premises and all facilities and equipment thereon have been inspected and that the undersigned finds and accepts same as being sound and reasonably suited for the purposes of such observation or use.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE JCPCDD FACILITY FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO OBSERVATION, USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANYWAY, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. The undersigned hereby releases, waives, discharges and covenants not to sue JCPCDD, its supervisors, officers, employees and agents (hereinafter referred to as "Releasees") from all liability to the undersigned, his/her personal representatives, assigns, heirs and next of kin for any loss or damage, and any claim or demand therefore on account of injury to the undersigned's person or property or resulting in death of the undersigned, whether caused by the negligence of the Releasees or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein;
2. The undersigned hereby agrees to indemnify and save and hold harmless the Releasees from any loss, liability, damage or cost they may incur due to the presence of the undersigned in, upon or about the JCPCDD premises or in any way observing or using any facilities or equipment of JCPCDD whether caused by the negligence of the Releasees or otherwise; and
3. The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage due to the negligence of the Releasees or otherwise while in, about or upon the premises of JCPCDD and/or while using the premises or any facilities or equipment thereon.

The undersigned further expressly agrees that the foregoing waiver, release, and indemnification agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Florida and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Nothing herein is intended or shall be construed as a waiver of JCPCDD's sovereign immunity or limitations of liability contained in section 768.28, Florida Statutes, or other law.

WAIVER FOR CHILD CARE, DAY CAMPS, YOUTH PROGRAMS, SWIM LESSONS AND ALL YOUTH CLINICS

I understand that Julington Creek Plantation Community Development District (JCPCDD) assumes no responsibility for injuries or illnesses that my child may sustain as a result of his/her physical condition or resulting from his/her participation in any athletic activities, sports program, the use of any equipment, exercise or any other activities of any kind whatsoever. I expressly acknowledge that I assume the risk for any and all injuries and illnesses that may result from his/her participation in these activities.

In consideration of the privilege of participating in JCPCDD activities or programs, I hereby voluntarily release and discharge JCPCDD, its agents, officers, supervisors, staff, and employees from any and all claims for injury, illness, death, loss or damage of any kind whatsoever that I or my child may suffer as a result of his/her participation in these activities.

I understand and agree that nothing herein is intended to be or shall be construed as a waiver of the JCPCDD's sovereign immunity or the limitations of liability found in section 768.28, Florida Statutes, or other law.

While JCPCDD will make every attempt to provide reasonable accommodations for mentally and physically challenged children, JCPCDD will not accept children that are (1) of danger to themselves, (2) of danger to others, or (3) a disruption to the normal activities making it unreasonably difficult for other children to enjoy JCPCDD programs. Any of the above reasons will be grounds for dismissal from JCPCDD programs. We strongly recommend that you discuss with JCPCDD staff any special conditions or circumstances involving your child. We request that you do this PRIOR to registration so that we can advise you as to whether we can make reasonable accommodation for your child.

I understand that JCPCDD is NOT responsible for personal property lost or stolen while members and/or program participants are using JCPCDD facilities or on JCPCDD premises.

In the event of an emergency and my emergency contact person cannot be reached, I hereby give my permission to the physician selected by JCPCDD to hospitalize, secure proper treatment for, and to order injections, anesthesia or surgery for the individual named on this application.

I understand that no accident or medical insurance is provided with this activity.

I give my permission to JCPCDD to use, without limitation or obligation, photographs, film footage or tape recordings that may include my child's image or voice for purposes of promoting or interpreting JCPCDD programs.

I give my permission for my child to be transported by the bus service secured by JCPCDD for related programs activities.
